- (c) dalam subperenggan 11(1)(c)(v) dengan menggantikan perkataan “Ketua Pendaftar Mahkamah Rayuan Syariah” dengan perkataan “Ketua Hakim Syarie”;
- (d) dengan memasukkan selepas subperenggan (v) subperenggan yang berikut:
  - “(vi) Pengarah Jabatan Agama Islam Negeri Perak; dan”;
  - dan
- (e) dalam perenggan 11(1)(d) dengan menggantikan perkataan “lima belas” dengan perkataan “dua puluh”.

### **Pindaan seksyen 16**

3. Seksyen 16 Enakmen ibu dipinda dengan menggantikan subseksyen (1) dan (2) masing-masing dengan subseksyen yang berikut:

“(1) Maka hendaklah ada seorang Ketua Pegawai Eksekutif bagi Majlis yang dilantik oleh Duli Yang Maha Mulia Sultan.

(2) Ketua Pegawai Eksekutif hendaklah menjadi Setiausaha dan Pentadbir Majlis dan hendaklah bertanggungjawab bagi menjalankan dasar-dasar dan ketetapan-ketetapan Majlis.”.

### **Seksyen baru 16A**

4. Enakmen ibu dipinda dengan memasukkan selepas seksyen 16 seksyen yang berikut:

#### **“16A Pelantikan Pengarah Jabatan Agama Islam Perak**

(1) Pengarah Jabatan Agama Islam Perak hendaklah dilantik oleh Pihak Berkuasa Negeri dengan perkenan bertulis Duli Yang Maha Mulia Sultan.

(2) Pengarah Jabatan Agama Islam Perak hendaklah mematuhi dasar-dasar dan ketetapan-ketetapan Majlis.”.

**Pindaan seksyen 69**

- 5.** Seksyen 69 Enakmen ini dipinda dalam subseksyen (3)–
- (a) dalam perenggan (a) dengan memotong perkataan “atau”;
  - (b) dalam perenggan (b) dengan menggantikan koma dengan “; atau”; dan
  - (c) dengan menambah selepas perenggan (b) perenggan baru yang berikut:  
    “(c) mana-mana anggota Skim Perkhidmatan Pegawai Syariah,”.

An Enactment to amend the Administration of the Religion of Islam (Perak) Enactment 2004.

**ENACTED** by the Legislature of the State of Perak Darul Ridzuan as follows:

**Short title and commencement**

**1.** (1) This Enactment may be cited as the Administration of the Religion of Islam (Perak) (Amendment) Enactment 2009.

(2) This Enactment comes into operation on such date as the State Authority may appoint by notification in the *Gazette*.

**Amendment of section 11**

**2.** The Administration of the Religion of Islam (Perak) Enactment 2004 [*Enactment No. 4 of 2004*], which is referred to as the “principal Enactment” in this Enactment, is amended in section 11–

- (a) in paragraph 11(1)(c) by substituting for the word “five” the word “six”;
- (b) in subparagraph 11(1)(c)(iv) by deleting the word “and”;
- (c) in subparagraph 11(1)(c)(v) by substituting for the words “the Chief Registrar of the Syariah Appeal Court” the words “the Chief Syariah Judge”;

(d) by inserting after subparagraph (v) the following subparagraph:

“(vi) the Director of the Islamic Religious Department of Perak; and”; and

(e) in paragraph 11(1)(d) by substituting for the word “fifteen” the word “twenty”.

### **Amendment of section 16**

3. Section 16 of the principal Enactment is amended by substituting subsections (1) and (2) respectively with the following subsections:

“(1) There shall be a Chief Executive Officer of the Majlis appointed by Duli Yang Maha Mulia Sultan.

(2) The Chief Executive Officer shall be the Secretary and the Administrator of the Majlis and shall be responsible for carrying out the policies and resolutions of the Majlis.”.

### **New section 16A**

4. The principal Enactment is amended by inserting after section 16 the following section:

#### **“16A Appointment of Director of the Islamic Religious Department of Perak**

(1) The Director of the Islamic Religious Department of Perak shall be appointed by the State Authority with the written consent of Duli Yang Maha Mulia Sultan.

(2) The Director of the Islamic Religious Department of Perak shall abide the policies and resolutions of the Majlis.”.



**Amendment of section 69**

**5.** Section 69 of the principal Enactment is amended in subsection (3)–

- (a) in paragraph (a) by deleting the word “or”;
- (b) in paragraph (b) by substituting comma with “; or”; and
- (c) by inserting after the paragraph (b) the following new paragraph:  
    “(c) any member of the Syariah Officer Services Scheme,”.
